MAINE ROWING CAMP PARTICIPANT AND PARENT AGREEMENT

IMPORTANT – PLEASE READ THIS AGREEMENT CAREFULLY

This document affects your legal rights, and must be signed by the Participant and, if the Participant is a Minor, by his or her parent(s) or legally appointed Guardian(s).

In consideration for the opportunity to participate, or for my or our child's opportunity to participate, in a summer Rowing Camp program operated by Maine Rowing Camp, a duly organized Maine Corporation ("MRC"), each person signing this Agreement agrees as follows:

1. Activities, Hazard, and Risks. Camp activities include physical activities on land and water that involve risks and dangers of serious bodily injury, including permanent disability, paralysis, and death. These risks and dangers may result from the actions or inactions of the Participant, or those of other Participants, the conditions in which Camp activity takes place, the equipment and facilities used in such activities, the weather, or the negligence of MRC, its Directors, Officers, Shareholders, Employees, or Agents ("Releasees") or from other causes. Without limiting the foregoing, risks and dangers may result from structure or equipment failure, submersion in water, errors in judgment by MRS Staff, Participant, or other campers. The undersigned acknowledge that this description of risks and dangers is not complete, and that all activities associated with the sport of rowing, whether described herein or not, may be dangerous and may include inherent risk that cannot be reasonably avoided without changing the nature of the activity.

2. Release and Covenant Not To Sue. Each person signing this Agreement releases, waives, and discharges from and covenants not to sue Releasees in connection any liability, including liability for negligence of Releasees, for loss or damage, claims or demands arising out of or related to Participant's enrollment and participation in the summer Rowing Camp program. This release is intended to be as broad and inclusive as is permitted by law.

3. Indemnification. Each undersigned Parent or Guardian indemnifies and holds Releasees harmless from:

- a. all loss or damage, claims or demands set forth in Paragraph 2 herein brought by, through or under himself or herself, his or her heirs, executors, or assigns; and
- b. all loss or damage, claims or demands set forth in Paragraph 2 herein brought by, through or under the Participant, his or her executors, heirs, or assigns.

Each Parent or Guardian agrees that he or she shall pay Releasees' reasonable attorney's fees and costs incurred in enforcing its rights hereunder.

Without limiting the foregoing, the provisions of this Indemnification provision extend to all loss or damage, claims or demands based upon Releasees' negligence, and are intended to be as broad and inclusive as is permitted by law.

4. Severability. If any provision of this Agreement shall be held by a Court of competent jurisdiction to be contrary to law, the remaining provisions will remain in full force and effect.

5. Complete and Unconditional Release. The undersigned intends and agrees that: (a) the provisions of Paragraph 2 constitute a complete and unconditional release of all liability to the greatest extent allowed by law; and (b) the provisions of Paragraph 3 are intended to provide indemnification to the greatest extent allowed by law.
