General Information

Am I Eligible

Colby College requires all registered full-time students to have health insurance coverage, either through this Student Health Insurance Plan or through another individual or family plan. Students are automatically enrolled in and billed for the Student Health Insurance Plan unless proof of comparable coverage is provided by completing the online waiver.

Dependents

Dependents are not eligible.

How Do I Waive?

To Waive:

Students who wish to have the expense for this coverage removed from the College charges may do so by providing other insurance information online. Students must verify that they have other adequate insurance coverage in order to waive automatic enrollment in the Student Health Insurance Plan. The deadline to waive coverage is August 1, 2023. For those students beginning in the Spring Term, the deadline to waive coverage is January 1, 2024. Students who complete the waiver by August 1, 2023 do not need to complete the waiver again for January. No waivers will be accepted after the deadline.

The Certificate does not cover Loss nor provide benefits for any of the following, except as otherwise provided by the benefits of the Certificate and as shown in the Schedule of Benefits.

General Exclusions
