For students considering Ph.D. level graduate study in economics we recommend: MA160 or MA165; MA253 (Linear Algebra); MA274 (Mathematical Reasoning); MA311 (Ordinary Differential Equations); MA338 (Real Analysis); and CS151 (Computational Thinking).

EC393/325 is a pre-requisite or concurrent requirement for all senior seminars.

For the economics majors, at least three of the four required courses EC223, EC224, EC293/225, and EC393/325 must be taken at Colby. Students may receive credit toward the majors or minor for no more than three courses taken away from Colby. EC121/210, EC133, and EC134 do not count toward this three-course limit.

No course that could fulfill a requirement for either major or minor may be taken satisfactory/unsatisfactory. This includes all EC-listed courses and any course used to fulfill the Statistics and Mathematics requirements.

Independent studies, EC293/225, EC393/325 and EC345 cannot be used to fulfill any of the elective course requirements.

The Economics minor cannot be combined with either of the Economics majors. A relevant internship experience is recommended for all majors and minors.

For the class of '26, new declarations of the minor are allowed only for those who have completed at least 4 of the 6 courses. For the class of '27, new declarations are allowed only for those who have completed at least 3 of the 6 courses.
